- 1. Call the meeting to order and proof of due notice of meeting and open meeting notice posted.
 - The meeting was called to order at 6:45 p.m. by President Ronnau

2. Roll Call

- 3. Approval of minutes from Dec. 2020 Annual Meeting not needed, already approved Jan. 2021
- 4. President's Report (Kendra Ronnau) thoughts on the year's progress
 - There was a great fair this year; everyone was happy to be back to a more normal fair in person after a limited pandemic fair in 2020. The word for 2021 as we celebrated our 150th anniversary as an Ag Society is "Wow." The first NHSFR rodeo was also incredible this year in July. We are indebted to the board and the LEC staff. We are working hard on securing ongoing funding and are on the right path. We are getting the city and State's attention for future support.
- **5.** Treasurer's Report (Rutt/Martin) high level financial status (Report given by Dickerson in place of Rutt/Martin).
 - End of year financials end in November 2021, so those are being prepared for January's board meeting. LEC final got approval after 5 months for a \$350K addition to our \$150K Economic Injury Disaster Loan. Due to the pandemic, it took much longer to process than previously. LEC is ending the year fairly strong and similar to previous years but is still looking to improve our financial sustainability going forward. application was denied because LEC does not sit in a qualified Census district, a more strict guideline than required by the federal ARPA law. This decision is being appealed.

6. LCAS Annual Election Results (Dave Shively, Lancaster Co. Election Commissioner)

 - Karen Rutt 26 votes
 - Kendra Ronnau 23 votes

a. LEC rolled 2020 Wall of Fame inductees into 2021, so no one new was announced in 2021 as 2020 inductees to be celebrated in November 2021 20th Anniversary Banquet.
